



PEDDLER

Definition

Going from house to house, place to place, or in or along the street, within the City, selling and making immediate delivery or offering for sale and immediate delivery, any goods or anything of value in possession of the peddler, or services of the peddler, to persons other than manufacturers, wholesalers, jobbers or retailers in such commodities. Peddling shall not include business by vehicle as herein described.

Requirements

- Seller's Permit (sales of merchandise).
- List of names of those who will be peddling.

Standard Conditions

FIRE DEPARTMENT

530. No stopping in front of the fire hydrants or other appliances.

PLANNING DEPARTMENT

964. Graffiti must be removed from vehicle(s) within seventy-two (72) hours following the application of the graffiti.

LICENSE DEPARTMENT

227. Provide a list on names of those who will be in the City peddling.
189. Peddlers may not use pressure tactics when peddling.
229. Selling directly from the vehicle is not permitted.
192. This permit is not valid without a current business license.
151. Applicant must provide a map of route and location stops within the City of El Monte and notify the License Department of any route or location stop additions and/or changes. This information will be kept confidential.
232. No peddler shall conduct any business within the boundaries of the parking and Business Improvement Area (Valley Mall).
51. Pursuant to **EMMC Section 5.12.260**, all other City fees and taxes must be paid in full as a prerequisite to the issuance of this permit. Should the permit holder default on the payment of any fee or tax due the City by any provision of law or of this Code, this permit shall become invalid.

CODE ENFORCEMENT

980. Peddlers shall go from house to house, place to place, as stated in **El Monte Municipal Code Section 5.04.010**
981. No peddling or sales activities shall be made or attempted after sunset.
982. All persons peddling under this permit shall be at least eighteen (18) years old.
983. All persons, while peddling under this permit, shall have and carry this permit, their business license, and a valid State of California Driver's License or Identification Card or other picture identification card issued by a State government other than California, on their person; and they shall present these documents to any City Code Enforcement Officer or Police Officer upon demand.



984. No person, while peddling under this permit, shall consume any alcoholic beverage nor possess any open container of an alcoholic beverage whether on public or private property.
985. No person peddling under this permit shall harass, coerce, threaten, or intimidate another person for the purpose of trying to sell them something.
986. No person peddling under this permit shall sell or peddle any product or thing that has been made, manufactured, produced, reproduced, copied or acquired in a manner that violates any City, County, or Federal Law. All items will be subject to confiscation/seizure and held for evidence. Peddlers will be subject to a citation.
234. All items will be subject to confiscation/seizure and held for evidence. Peddlers will be subject to a citation.
