



## AMBULANCE

### Definition

The City of El Monte is responsible for the licensing of private ambulance. Ambulance means a vehicle equipped for taking sick or injured people to and from hospital, especially in emergencies.

### Requirements

1. A copy of Insurance Policy  
(Certificate of Liability)
  - a. Insurance *must not expire* during the term  
Of the permit. *(No exceptions)*
  - b. Policy must include an endorsement naming the  
*City of El Monte, its City Council and its officers,  
agents and employees as additional insured.*
  - c. Policy must include an Endorsement which provides  
that *30 days written notice for cancellation of the  
policy for any reason* will be provided to the City of  
El Monte.
2. Schedule of Rates.
3. Color scheme, insignia or design of vehicle. *(photo)*
4. List of all vehicles operating in El Monte.  
*(From insurance company)*
5. Copy of Vehicle Registration for all vehicles operating in  
El Monte.
6. ALL NEW APPLICANTS MUST HAVE A LOS ANGELES  
COUNTY AMBULANCE OR AMBULET OPERATOR'S  
PERMIT.

Standard Conditions

POLICE DEPARTMENT

203. All vehicles shall be maintained in a safe operating condition and in compliance with all applicable mechanical requirements set forth in the California Vehicle Code.
836. Effective January 1, 2006 applicant shall obtain and possess at all times a valid Ambulance Operator's License or Ambulette Operator's License issued by the County Of Los Angeles Department of Health Services Emergency Medical Services Agency.
837. Applicant and its employees shall comply at all times with the provisions of either Chapter 7.16 of the Los Angeles County Code if licensed as an Ambulance Operator Or the provisions of Chapter 7.17 of the Los Angeles County Code if licensed as an Ambulette Operator and all other rules and regulations of the County of Los Angeles Applicable to Ambulance and Ambulette Operators.
838. Applicant shall at all times be in compliance with the provisions of Title 22 Division 9 Chapter 12 of the California Code of Regulations and all other rules and regulations of The State of California and the California Highway Patrol applicable to Ambulance And Ambulette Operators.

LICENSE DEPARTMENT

42. Applicant must provide proof of insurance which meets the standards set forth in **EMMC Section 3.24.160**. This insurance must be in effect throughout the term of the permit. Expiration / cancellation of a policy during the term of the permit shall be cause of immediate revocation of the permit.
51. Pursuant to **EMMC Section 5.12.260**, and all other City fees and taxes must be paid in full as a prerequisite to the issuance of this permit. Should the permit holder default on the payment of any fee or tax due the City by any provision of law or of this Code, this permit shall become invalid.

PLANNING DEPARTMENT

964. Graffiti must be removed from vehicle(s) within seventy-two (72) hours following the application of the graffiti.
847. All applicants shall obtain and possess at all times a valid ambulance operator's license or ambulette operator's license issued by the County of Los Angeles Department of Health Services Emergency Medical Services Agency. Any applicant that was licensed in the City of El Monte as an ambulance provider prior to January 1, 2006 shall be exempt from this requirement provided that the applicant has been continuously licensed with the City of El Monte as an ambulance provider since calendar year 2005 with no interruption in Service to the City of El Monte or failure to renew their City of El Monte business license And ambulance operator's permit.
