ENERGY STANDARDS

Energy Standards Plan Check

The following conditions would require energy plan review independently, or in conjunction with Code Plan Check:

- D All new buildings and additions (heated and/or cooled)
- D All new tenant improvements adding heating and/or cooling systems to existing conditioned spaces or to buildings in which the envelope was previously approved for compliance with the Energy Standards
- D All alterations to the envelope of any building
- D All newly installed or altered ductwork
- D All shell buildings
- D New construction, tenant improvement installations, and alterations with a conditioned/unconditioned floor area greater than 1,000 square feet will require review to verify compliance with the California Building Energy Efficiency Standards
- D New construction, tenant improvements and alterations with the outdoor illuminated area greater than 30,000 square feet - or - the addition/modification of outdoor luminaires of 3,200 watts or greater

****ART IN PUBLIC PLACES****-This fee is applicable to projects whose total valuation exceeds \$500,000 or is a Planned Unit Development (PUD) consisting of 4 or more units. Construction & Demolition Compliance: The City of El Monte, in accordance with adopted State of California recycling requirements, has partnered with Valley Vista Services for recycling of construction debris. When any construction or demolition is taking place, a bin rental is required. Additionally, depending on the scope of work, a bond may be required as well. Proof of services with the appropriate waste hauler and/or bond payment must be obtained prior to permit issuance. Obtain C&D questionnaire & forms from the Building Division

Furthermore, I am aware that if the building plans have been reviewed and I cannot obtain the necessary approvals from the other agencies, the fees paid to the Building and Safety Division for plans will be forfeited. I understand that additional plan check fees may apply if the plans submitted are modified in order to obtain approvals from other agencies. Also, plan check is valid for one year; additional fees may be required after one year for renewal.
